- Includes a Bank of America Lunch & Learn to provide assistance and access to Bank Accounts and financial literacy lessons

To fill the 7 available Salt Lake County Summer Intern Program positions, we will intentionally reach out to students who can benefit from this experience, provide them with trajectory-changing experiences, and lean strongly into equity, access, and inclusion. Our goal is to fill a majority, if not all, SLCo Summer Internship positions with ethnically underrepresented, Low-to-Moderate Income students.
