This adjustment requests an appropriation of \$50K, with matching revenue to make it budget neutral. Grant funds will be used for the following:</p> <p>Providing Business Recovery Assistance to Salt Lake County businesses to assist in their recovery from the impact of COVID-19, to include but not limited to the Economic Inclusion Community Assistance Program (EICAP). These funds will be used to fund activities working with Community Partners to assist businesses most affected by COVID-19.
