Council Member Theodore delivered an invocation.

Pledge of Allegiance

Council Member Newton led the Pledge of Allegiance to the Flag of the United States of America.

Council Member Stringham led the State Pledge.

2. CITIZEN PUBLIC INPUT**3. REPORT OF ELECTED OFFICIALS:****3.1. Council Members**

Council Member Alvord expressed his sympathy to the deputies shot and injured at the Sheriff's Office. Law enforcement officers put their lives on the line without working for a lot of pay. He pledged support to make sure their salaries were competitive or above.

He also asked the Mayor to look at reopening recreation facilities so people can exercise. People face many health risks and Covid is just one of them. He has also received complaints that the County facilities are not open for high school swim teams or hockey players. The risk to youth is pretty low for Covid.

Council Member Snelgrove stated the County might be doing more harm than good by making its recreation centers and facilities less accessible rather than opening them up for greater usage. One of the side effects of Covid has been an average weight gain of 18 pounds, and before Covid, obesity was the number one health issue in America.

Council Member Theodore stated she has received complaints about the recreation centers not being open or having reduced hours. People are eager to start using them. Physical fitness is good for health.

Council Member Bradley stated he wanted to ensure people would not be at greater risk by reopening the facilities.

Council Member Granato stated she has been utilizing the Millcreek Recreation Center and commended the staff there.

3.2. Other Elected Officials

Mr. Sim Gill, District Attorney, announced that the District Attorney's Office has hired Jared Smith as the new Risk Manager to replace Jeff Rowley who left the County. He has a wealth of experience as a Risk Manager. Also, Jim Winder, Chief of Investigations, is leaving the County. The District Attorney's Office will be appointing Joe Tarver, Assistant Chief, Murray City Police Department, to fill that position. He will start the beginning of May.

3.3. Mayor

Mayor Jennifer Wilson stated her office is talking about reopening recreation facilities and can schedule something on an upcoming agenda to explain the work that is being done to balance everything.

She also recognized the deputies that had been shot, and thanked deputies and their families.

Additionally, she announced that the Larry Miller Group has been acquiring undeveloped property at Daybreak. The Larry Miller Group and Gail Miller met with her and are interested in partnering with the County for the expansion of the Daybreak community. They are interested in a park and perhaps open space. There may also be some opportunity for development.

WITNESSETH
