
# **SLCO Emergency Rental Assistance Program**

SLCO's initial ERAP allocation = \$29,052,934

(Received Jan. 22, 2021)

#### Funds can be used for:

- Rent (current and arrears back to March 13, 2020)
- Utilities, including electric, gas, sewer, water, trash removal, energy costs, internet (current and arrears)
- Housing-stability services
- Application portal launched on March 15, 2021
- Partnership with Salt Lake City and State of Utah on portal creation
- Over 13,000 SLCO residents have benefited from assistance
- Program progress reported weekly on dashboard






### **Emergency Rental Assistance Grant Program**

ERAP Community Grant Program provides funding to 21 organizations within SLCo to provide education & outreach and application assistance for the Emergency Rental Assistance Program. Program Launched May 25, 2021. Total program cost \$712,000.

379 Posts Created on Social Media
489 Individual Meetings Conducted
4,500 Flyers Distributed
413 Doors Knocked

## **Additional Housing Assistance**

### **Emergency Rental Assistance 2.0**

- ERAP 1.0 SLCO allocation \$29,052,934, received Jan 22, 2021
- ERAP 2.0 funding (two tranches) SLCO full allocation \$22.97 Million (\$11.6 Million, first tranche received May 19, 2021) (\$11.37 Million, second tranche receipt dependent on ERAP 1.0 spending)
- Must spend 65% of ERAP 1.0 (\$16 Million of \$29 Million) by Sept 30, 2021 to receive 2<sup>nd</sup> tranche
- SLCO is on track to meet the spend down requirements to receive the 2<sup>nd</sup> tranche

### Mortgage Assistance

- ARPA included \$9.4 Billion nationally in Mortgage Assistance
- State of Utah received \$66 Million
- State is working on how to implement the program
