Council Member DeBry asked everyone to comply with the mask mandate issued by Mayor Jennifer Wilson, requiring masks to be worn in County facilities. He stated there is no vote on the agenda today relating to masks mandates. He asked citizens who wished to address the Council to make comments on items that will be considered during its meeting today.

The Council may exercise its discretion to limit the total amount of time allowed for comments by members of the public, as well as the total number of speakers and/or the amount of time that each member of the public is allowed to speak.

Preference will be given to Salt Lake County Residents who intend to address matters on the Council Work Session agenda.

The following citizens spoke in opposition to a mask mandate because it is about control and not about masks. Leaders should focus on other ways to prevent the spread of Covid.

Mr. Adam Cota spoke in favor of a mask mandate. He encouraged the Council to take some action because the pandemic is not over, rates continue to climb, and Covid will not cure itself.

The following citizens spoke in favor of constructing a gondola in Little Cottonwood Canyon to move people up and down the canyon because it is reliable, it reduces the number of vehicles on the road, the canyon road is dangerous in winter, it is good for air

and water quality, it provides a better user experience, it is a safe mode of transit during natural disasters, and it is less intrusive.

The following citizens spoke in opposition of the construction of a gondola in Little Cottonwood Canyon because it is too expensive; a bus system would be more flexible; it is a commercial interest based on faulty data; there would still be traffic in the canyon; it is not a mass transit solution, it is a tourist attraction; the gondola proposal contains avalanche sheds; people will continue driving; a gondola will alter the beauty of the canyon; it will only move 1,000 people per hour; it will impact the watershed; and the ski areas and developers will benefit from this, not the taxpayer. Citizens also encouraged the use of interim alternatives such as mandatory carpooling, prohibiting roadside parking peak hours, and the use of additional buses and shuttles.

Mr. Alan Orr stated the primary cause of congestion in Little Cottonwood Canyon is due to the weather and slick roads associated with snowfall. Both alternatives would take years to complete. He suggested short term solutions be put in place that would help with congestion. These solutions included traction laws, snow removal earlier in the morning, and prohibiting roadside parking,

Mayor Harris Sondak, Town of Alta, stated his community is concerned about the effect of both options. They are both too expensive and exceeds the value in terms of return of investment. More incremental solutions needed to be put in place such as traction requirements, dedicated a lane of egress, and increased bus and van services.

The following citizens spoke in opposition to the proposed language in Policy #4-200 relating to replacing the word mother to a birthing parent because it is a denial of facts, it is an insult to people who have children, to remove the gender is an attack on families, genders do not change, an mother is important, there are 346 references to mother in the scriptures, a mother is the bedrock of our civilization, words have meaning, the term birth

Dr. Angela Dunn, Director, Salt Lake County Health Department, delivered a PowerPoint presentation on the Covid-19 update showing the 7-day Covid ICU utilization increased by 4 percent; the 5-11 year-olds case rate is eight times higher than last year; 17 percent of cases are children under 12; ages 5-11 have the highest case rate among children; elementary schools lead cases among education; there is an 18 percent increase in the 7-day case count since last week; the 7-day case count is 174 percent higher than last year; there have been 425 school associated cases since school started, and 917 cases in school age children since August 16; 64 percent of residents 12+ are fully vaccinated; 12-17 year-olds case rates are increasing faster than other ages; low vaccine coverage results in higher case rates; Salt Lake County ICUs are at capacity today.

Ms. Catherine Kanter, Deputy Mayor of Regional Operations, delivered a PowerPoint presentation regarding a letter written by Mayor Jennifer Wilson and Council Member Bradley about the Utah Department of Transportation's Little Cottonwood Canyon (LCC) Draft Environmental Impact Study (DEIS). The PowerPoint highlighted the background of the study, its context, the two recommendations (enhanced bus/shoulder alternative or a

gondola), proposed phased approach investment/techniques, benefits of an enhanced bus/shoulder lane alternative, additional considerations, and federal legislation that should be adopted. Official comments on the proposals by UDOT are due Friday, September 3, 2021.

Council Member DeBry stated this is not scheduled for an official vote by the Council. He has not made up his mind and would like to hear from both sides. He asked Chris McCandless, CW Management Corporation, to take 10 minutes to review the proposed gondola recommendation.

Mr. Chris McCandless, CW Management Corporation, stated he could not do this justice in 10 minutes and would like to come back before the Council later. He then went over the top ten reasons why a gondola would be a good alternative and showed a video on the proposal.

Mayor Jennifer Wilson stated if the Council is going to hear from Mr. McCandless, it should also hear from the other side, particularly Save Our Canyons and other groups that have an interest in this proposal.

Ms. Kathleen Johnston, Director, Human Resources Division, stated the proposed changes to this policy adds Juneteenth (June 19th) as an official County holiday. It also makes changes in the wording in several sections and includes language to follow what is in the Family Medical Leave Act (FMLA). When the policy went before the Steering Committee for review, it recommended the policy remain gender neutral so "birthing mother" was replaced with "parent giving birth." The benefits provided under this policy have not changed.

Council Member Bradshaw asked for an explanation from legal counsel as to why the term should be changed. He thought this language was needed to

follow federal direction.

Mr. Zachary Lancaster, Deputy District Attorney, stated a Supreme Court case defined sex to include sexual orientation and/or sexual identity. If that is not changed, the policy would be in violation of Title 7.

Mayor Jennifer Wilson stated for the record she is a mother and loves mothers.

A motion was made by Council Member Alvord, seconded by Council Member Theodore, that this agenda item be approved and forwarded to the 4:00 PM Council meeting for ratification, changing the wording in paragraph 2 (a) to read "birth mother," instead of "birth parent."

Council Member Alvord stated the definition is any person that carries a child during the gestational period. It is very important that it be noted that the County in no way plans to discriminate against any person.

Council Member Bradshaw asked if this language was approved by the District Attorney's Office.

Mr. Lancaster stated no, it has not been approved.
