Dear Council Members,

A recent decision of the Utah State Tax Commission orders Salt Lake County to adjust the 2019 Market Value on the above property from \$ 2,487,400 to \$ 2,300,000. This changes the 2019 property taxes from \$30,261.71 to \$27,981.80. The taxpayer has paid \$ 30,261.71 which results in an overpayment of \$ 2,279.91. The attached list of parcels were also appealed to the State Tax Commission with NO VALUE CHANGE made.

Based on the order of the Utah State Tax Commission, we recommend that the Council authorize the County Treasurer to issue a refund to the owner of record in the amount of \$ 2,279.91 with interest to be calculated by the County Treasurer at the appropriate rate as provided by State Statute and to release any or all BoE refunds.
