#### RECITALS

WHEREAS, Autonomy, Inc. (the "Owner") owns two parcels of real property located at 9021 West Magna Main Street, Magna, Utah, identified as Parcel Nos. 14-30-209-026-0000 and 14-30-209-027-0000 (collectively the "Property"); and
