RESOLUTION NO. 5770

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL DECLARING CERTAIN REAL PROPERTY SURPLUS AND AUTHORIZING EXECUTION OF A REAL ESTATE PURCHASE AND SALE AGREEMENT WITH UTAH’S AQUATICS ACADEMY, LLC, AND RELATED DOCUMENTS

W I T N E S S E T H

A. Salt Lake County (the “County”) owns fee title to a parcel of real property located at 10300 South Redwood Road, South Jordan, Utah, identified as Parcel No. 27-15-127-015 (the “County Property”).

B. Utah’s Aquatics Academy, LLC, a Utah limited liability company

("Utah's Aquatics"), has approached the County about purchasing the County Property.

C. Utah's Aquatics has offered to purchase the property for \$1,500,000.00, which has been negotiated and approved by Salt Lake County Real Estate Division as a fair market value for the County Property.

D. The County and Utah's Aquatics have negotiated to convey the County Property pursuant to the terms and conditions of a Real Estate Purchase and Sale Agreement ("Purchase Agreement") attached hereto as Exhibit 1.

E. Having held a public hearing on July 21, 2020, and having provided notice, the County may now declare the County Property surplus and dispose of it.

F. It has been determined that the best interests of the County and the general public will be served by conveying the County Property to Utah's Aquatics as proposed in the attached Purchase Agreement. The conveyance of the County Property will comply with all applicable state statutes and County ordinances.

RESOLUTION

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the County Property is hereby declared surplus property.

IT IS FURTHER RESOLVED by the Salt Lake County Council that the County Property shall be conveyed to Utah's Aquatics by special warranty deed in accordance with the terms of the Purchase Agreement attached hereto as Exhibit 1 and by this reference made a part of this Resolution; and the Mayor is hereby authorized to execute said Agreement.

IT IS FURTHER RESOLVED by the Salt Lake County Council that the Mayor and County Clerk are hereby authorized to execute such other documents as may be reasonably necessary to effectuate the closing contemplated by the approved Purchase Agreement including but not limited to the Special Warranty Deed in substantially the same form attached as hereto as Exhibit 2.

RESOLUTION NO. 5771

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL AGREEING TO THE NORTH POINTE RANCHES ANNEXATION BY NORTH SALT LAKE

WHEREAS, the city of North Salt Lake in Davis County supports what has been titled the North Pointe Ranches Annexation, through which North Salt Lake would annex a portion of what is currently unincorporated Salt Lake County as shown on the map attached as Exhibit A; and

WHEREAS, the proposed annexation is controlled by Utah State Code Section 10-2-401, *et seq.*, which states at Section 10-2-403 that “the process

to annex an unincorporated area to a municipality is initiated by a petition as provided in this section;” and

WHEREAS, pursuant to Utah Code Section 10-2-403(3), a petition to annex an area located in a county other than that of the proposed annexing municipality may not be filed unless the petition contains a resolution approving the annexation from the legislative body of the county in which the area proposed for annexation is located, and if the legislative body does not approve of the proposed annexation it must provide a written explanation; and

WHEREAS, North Salt Lake has provided evidence, attached as Exhibit B, that appears to demonstrate that the proposed annexation is supported by a significant number of affected property owners within the area proposed for annexation; and

WHEREAS, without the County Council’s preliminary approval to the proposed annexation, North Salt Lake would be prohibited from filing an annexation petition and initiating the annexation process, thus denying all interested parties the opportunity to meaningfully engage in the process provided by Utah law to fully review the proposed annexation and determine if it is lawful, has sufficient community support, and is otherwise in the public’s best interests;

NOW THEREFORE, BE IT RESOLVED, THAT:

For the limited purpose of meeting the requirements of Utah Code Section 10-2-403(3), Salt Lake County, though neither in favor of nor opposed to the proposed North Pointe Annexation, and without passing on the wisdom or legality of the proposed annexation, hereby approves the proposed North Pointe Ranches Annexation.
