ORDINANCE NO. <u>1892</u>

REQUIRING THE POSTING OF ADDITIONAL PHYSICAL NOTICE INFORMING MEMBERS OF THE PUBLIC ABOUT CERTAIN LAND USE HEARINGS

AN ORDINANCE OF THE LEGISLATIVE BODY OF SALT LAKE SECTION 19.90.020 OF THE SALT COUNTY. UTAH. AMENDING LAKE COUNTY OF ORDINANCES. 2001. CODE ENTITLED "HEARING - NOTICE" TO REQUIRE THE POSTING OF PHYSICAL SIGNS INFORMING MEMBERS OF THE PUBLIC ABOUT CERTAIN LAND USE HEARINGS AND RELATED MATTERS

The County Legislative Body of Salt Lake County ordains as follows:

SECTION I. The amendments made herein are designated by underlining the new substituted words. Words being deleted are designated by brackets and strike-through.

SECTION II. Section 19.90.020 of the Salt Lake County Code of Ordinances, 2001 is hereby amended to read as follows:

19.90.020 - Hearing - Notice.

<u>A.</u> Before finally adopting any such amendment, the County Council shall consider the application during a public [meeting] hearing which has been properly noticed in compliance with the provisions of <u>Title 17a</u>, <u>Chapter 2</u>, <u>of the County Land Use</u>, <u>Development</u>, and <u>Management Act</u>, <u>Title 52</u>, <u>Chapter 4</u>, of the Open and Public Meetings Act, <u>and section 2.04.150 of the Salt Lake County Code of Ordinances</u>.

B. In addition to providing notice required by subsection A., at least ten calendar days before the public hearing considering any such amendment, the county shall post physical notices on the parcel of property being rezoned using a sign of sufficient durability, print quality, and location that is reasonably calculated to give notice to passerby. The sign shall be bright orange in color and shall be no smaller than 24" x 36" in size.

1. The County shall take photo verifying that the notice has been posted. The County shall inspect and verify, with another photo, at least one other time during notice period. This verification shall be included in the application packet for the public hearing.

2. This posted notice should include the following: type of hearing, date, time, location, description of land use application, and County contact information.

3. If this posted notice is destroyed or disappears during the notice period, the County's ability to hold the public hearing will not be delayed, and it will not affect the validity of decisions made at the public hearing.

SECTION III. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication in a newspaper published and having general circulation in Salt Lake County.

Council Member Granato asked if the Council can change the amount it allocates.

Mr. Mitchell Park, Legal Counsel, Council Office, stated yes, the Council can decide how much to allocate.

Council Member Alvord withdrew his motion.

A substitute motion was made by Council Member Alvord to allocate \$2 million of ARPA funds for this project. The motion died due to a lack of a second.

Mr. Jevon Gibb, Director, Economic Development, stated the funding is needed to keep the experts in place. If the funding goes away, then the experts will go away. It has taken nine months to get to this point and he did not want to lose the momentum now and have to start all over.

RESOLUTION NO. <u>5953</u>

A RESOLUTION OF THE SALT LAKE COUNTY COUNCIL AUTHORIZING EXECUTION OF A SUBDIVISION PLAT IN SOUTH JORDAN

RECITALS

A. Salt Lake County (the "County") owns several parcels of real property located in South Jordan, known as the Equestrian Park ("Park Property").

B. The County has entered into an Interlocal Agreement to convey most of the Park Property to Utah State University.

C. In order to convey the property to Utah State University, the County needs to prepare and record a subdivision plat (the "Plat") to consolidate lots for Utah State University and to create a separate lot that will be retained by the County.

D. The Plat will also dedicate a portion of the Park Property to the public because the portion is located in the right-of-way for 2200 West and is already incorporated into the public road system (the "Dedication Property"). A copy of the Plat is attached hereto as Exhibit A.

E. It has been determined that the best interests of the County and the general public will be served by executing the Plat attached to this Resolution.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the Dedication Property is hereby declared available for disposal and may be dedicated for public use as part of the public road system. IT IS FURTHER RESOLVED by the Salt Lake County Council that the Plat, attached hereto as Exhibit A, is hereby approved, including permitting the Dedication Property to be dedicated to the public for use a public roads, and the Mayor and County Clerk are hereby authorized to execute the Plat in substantially the form attached as Exhibit A for recording.
