#### 3.1. Council Members

**Council Member Alvord** stated he recently attended the second annual Great Salt Lake Summit hosted by Utah House Speaker Brad Wilson. It took place in Weber County and was well attended. The State is focusing on some new technology and farming techniques that use less water.

**Council Member Stringham** stated she was able to attend the Governor's One Utah Summit, which took place at Southern Utah University (SUU). It was well attended, and there was a lot of good information given.

Council Member Newton stated the Governor's Office and SUU recently started a Utah Rural Summit. She represented the County last year, but Council Member Stringham will take over this year. Most participants are county staff or elected officials, and it is a great opportunity to learn about budgeting, government relations, networking, etc.

Council Member Newton also reported on her work with Circle Salt Lake, which

works to end intergenerational poverty. She was asked to moderate a panel for women focusing on the fiscal cliff. Sometimes people who receive government benefits will deny raises or promotions to avoid losing those benefits. This panel was created to address that issue. Circle Salt Lake is working with the Department of Workforce Services and the Utah Chamber of Commerce on developing a fiscal cliff calculator that will show how benefits are affected by wage increases.

Ms. Kerri Nakamura, Chief of Staff, Mayor's Office, stated Salt Lake County has been officially recertified by Welcoming America as an official Welcoming County for another three years. The program was launched in 2017, and the standard for becoming certified is set high. Salt Lake County was the first in the nation to be certified in 2018. Joseph Genda, New American Refugee Liaison, Mayor's Office, has led a vigorous audit process to evaluate Salt Lake County's compliance with the welcoming standard. This is a reaffirmation of the County's commitment to supporting all residents, including immigrants and refugees.

RESOLUTION **OF** THE **SALT** LAKE COUNTY Α **DECLARING** COUNCIL **SURPLUS REAL** PROPERTY APPROVING CONVEYANCE OF THE AND THE **OUIT CLAIM** DEED TO KEVIN P. LAWLOR AND ANNE LAWLOR

#### **RECITALS**

- 1. Salt Lake County (the "County") owns a parcel of real property, Parcel No. 16-08-476-043, located at 1209 East Laird Ave, Salt Lake City, Utah (the "Property").
- 2. Kevin P. Lawlor and Anne Lawlor ("Buyers") own a parcel of land adjacent to the Property.
- 3. The County has determined that the Property was severed from Buyers' property and struck off to the county through a tax sale in 1936.
- 4. The Property is currently the subject of a quiet title action filed by Buyers in the Third District Court (Lawlor v. Taylor, Case No. 210904949). As part of this transaction, Buyers have agreed to dismiss the County from the lawsuit.
- 5. Buyers have offered to purchase the Property from the County for its appraised value, which has been reviewed and approved by the Salt Lake County Real Estate Division, and has paid a fee of \$100, which amount shall be credited towards the purchase price of the Property. This offer is in the form of a Tax Sale Property Purchase Agreement (the "Agreement") attached hereto as Exhibit A.
- 6. The County has determined that the Property is not currently in public use and that the Property has an appraised value of \$4,800.00. Proceeds from the sale of the Property will be distributed in accordance with Section

59-2-1351.5 of Utah Code.

7. The best interest of the County and the general public will be served by the sale and conveyance of the Property to Buyers for its fair market value. The sale and conveyance will be in compliance with all applicable state statutes and county ordinances.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Salt Lake County Council that the Property described in Exhibit 1 of the Agreement is hereby declared surplus property.

IT IS FURTHER RESOLVED by the Salt Lake County Council that the sale and conveyance of the Property by quit claim deed to Buyers as provided in the Agreement for the agreed appraised value of Fur Thousand Eight Hundred Dollars (\$4,800.00) is hereby approved; and the Mayor is hereby authorized to execute the Agreement and the Mayor and County Clerk are authorized to execute the Quit Claim Deed, attached to the Agreement as Exhibit 2, and to deliver the fully executed documents to the Salt Lake County Real Estate Division for delivery to Buyers in accordance with the terms of the Agreement.
