Topic/Discussion Title:

A resolution of the Salt Lake County Council approving execution of Amendment No. 1 to the interlocal cooperation agreement with the Cottonwood Heights Community Development and Renewal Agency. The ILA contract number is 0000001789 and Amendment No. 1 increases funding to \$7.75M of County Transportation Funds.

Description: Previously, the County Council approved funding to Cottonwood Heights in the amount of \$6M to acquire a perpetual public parking easement on a parking structure to be constructed within the Canyon Centre Community Development Project Area. Amendment No. 1 increases the amount of the funding to \$7.75M of County Transportation Funds. Additionally, Amendment No. 1 identifies SB 128 (2018) as the source of the funds rather than HB 420 (2015) since the 2018 Legislature provided funding for parking facilities in a county of the first class that facilitate significant economic development and recreation and tourism within the state.
