Requested Agenda Item Description: Salt Lake County has been working on a project to connect the Jordan River Trail to the current terminus of Parley's Trail at 900 West. Construction bids have been opened, and the amounts exceed the project's available budget. Parks & Recreation requests this adjustment to increase the project's expense budget to begin construction by increasing the budget to account for a new grant, by unassigning previously received grant revenues that have fallen to fund balance, and by transferring available budget from substantially complete projects.
